ISSUE: Des Moines Area Metropolitan Planning Organization Amended Invoices to CIRTPA for Fiscal Year 2022

REPORT AND VOTE: Report and approval of the Des Moines Area Metropolitan Planning Organization (MPO) Amended Invoices to CIRTPA for Fiscal Year 2022

BACKGROUND:

The MPO staff has discovered an error in the 1st and 2nd Quarter invoices to CIRTPA for FY 2022. The table below summarizes the original invoice amounts and what the correct amounts should have been:

Quarter	Original Amount	Correct Amount	Difference
1	\$28,502.00	\$17,667.00	\$10,835.00

Total	\$80,107.00	\$75,038.00	\$5,069.00

The invoice errors on the 1st and 2nd Quarter invoices resulted in the MPO over billing CIRTPA by \$5,069 in FY 2022. This was discovered prior to the MPO finalizing the 4th Quarter payment. Staff proposes that the \$5,069 refund be applied to the 4th quarter payment. The amended payment to the MPO for the 4th Quarter would be \$13,533.

A copy of the MPO 4th Quarter Fiscal Year 2022 Invoice will be made available prior to the meeting.

ISSUE: Suballocation Funding for the City of Adel

REPORT AND VOTE: Report and approval of the City of Adel's potential STBG suballocation.

BACKGROUND:

December 2021 was the first Funding Subcommittee meeting where an overview of the STBG suballocation process was provided. Additional discussion focused on the different ways that the City of Adel could receive an STBG funding suballocation. Generally, the committee expressed a desire to retain the existing STBG suballocation framework.

The Funding Subcommittee had another meeting earlier this month and reviewed various funding scenarios based on different criteria. A concession was not reached however the committee did request additional information, most notably how much funding Dallas County would be reduced by if Adel's population was not counted in the funding formula. That information will be provided prior to the meeting.

The Subcommittee expressed a desire to make a decision relatively soon so that the City of Adel can incorporate whatever determination is made by CIRTPA into its planning process.
